S.J.D. PROGRAM

The small and highly selective S.J.D. (Doctor of Juridical Science) Program is geared toward those who seek to pursue careers as teachers and scholars of law. S.J.D. students enroll in courses at the law school for two semesters and will normally submit and defend a dissertation within two years of completion of the coursework period. Prior to matriculation, applicants must have received a professional degree in law (*i.e.*, J.D. or LL.B.) and an LL.M. degree.

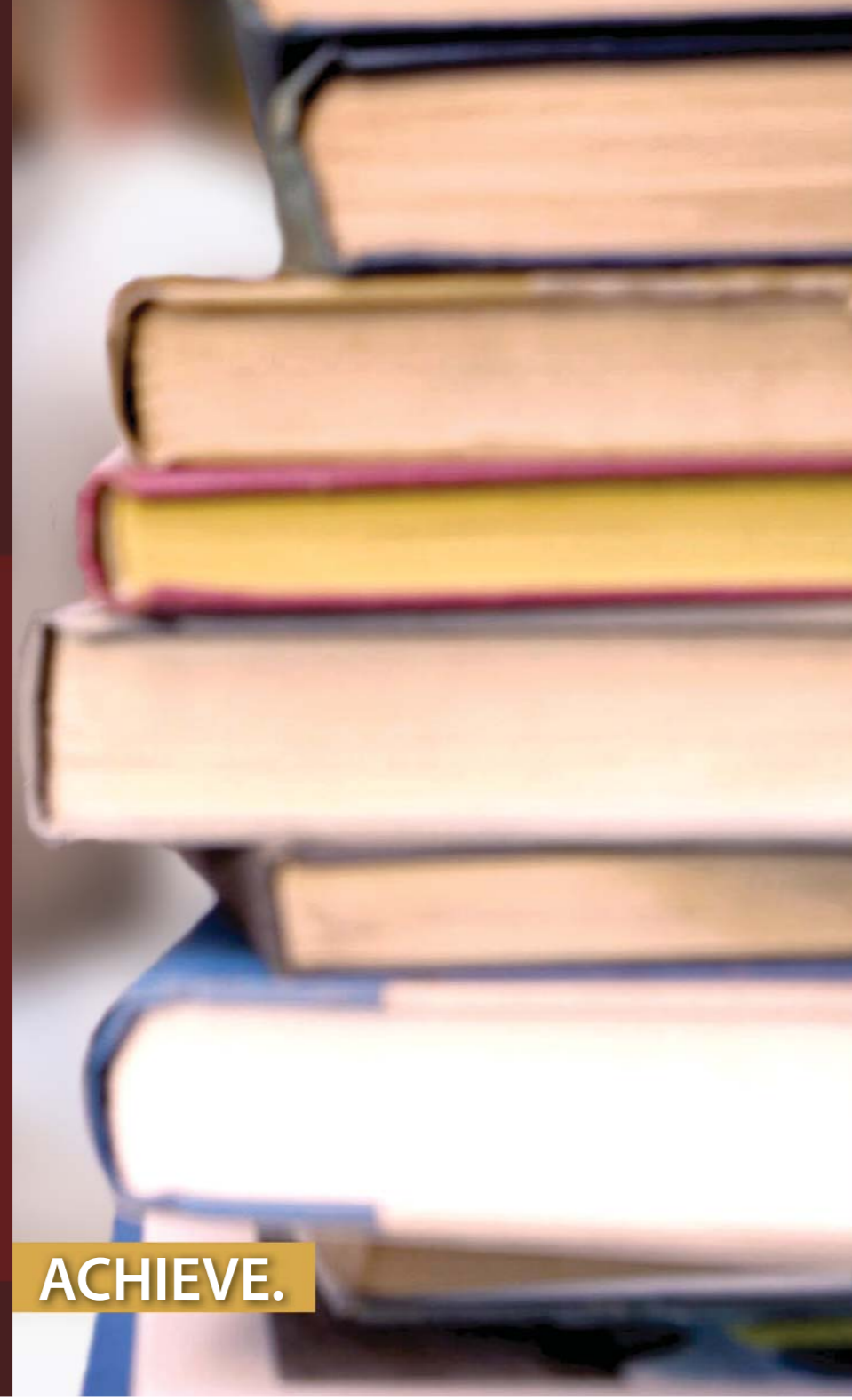

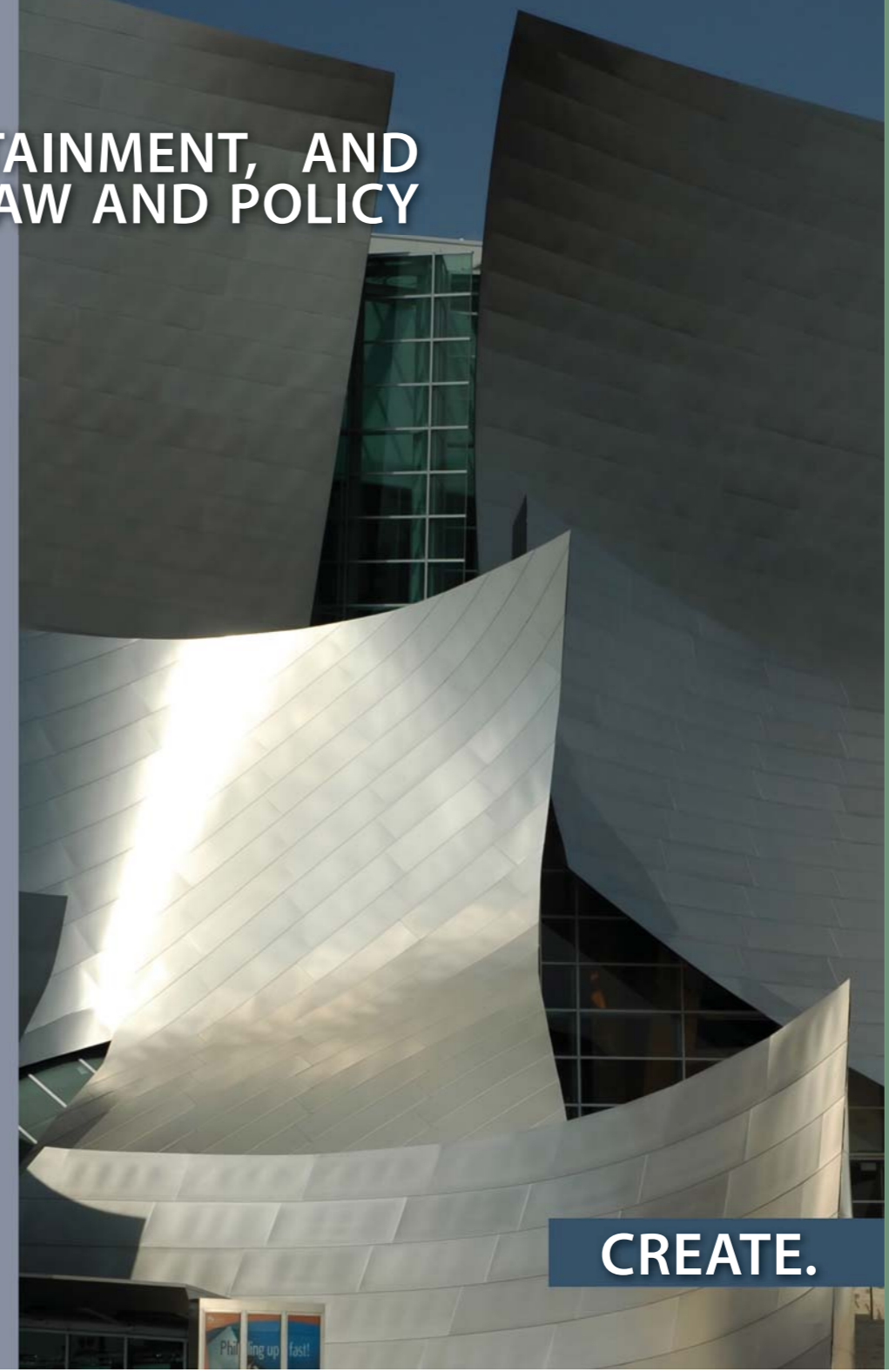
